



### For 2-3 year olds

All fees are charged on a calendar month basis and are payable on or before the first day of each calendar month. A returnable deposit is required when a place is accepted.

Fees are payable for the number of days your child is due to attend nursery over the school year, divided into 12 monthly payments. Invoices will be issued at the start of the school year.

For children not in receipt of Early Years Funding (“EYF”) the following fees are applicable from the month after the one in which your child turns two years of age:

<b>Hourly Rate – for children <u>not eligible</u> for EYF</b>		
	<b>Attending 2-3 days per week</b>	<b>Attending 4-5 days per week (approx. 10% discount)</b>
<b>Full day</b> (8.30am – 5.30pm) 9 hours long	£9.25	£8.33

For those children eligible for EYF, the following fees are applicable from the term after the one in which your child turns two years of age:

<b>Full day</b> (8.30am – 5.30pm) 9 hours long	Funded hours are charged at £1.25 per hour and the balance at £9.25 per hour	Funded hours are charged at £0.33 per hour and the balance at £8.33 per hour

EYF is available to eligible parents for 38 term-time weeks per year. Since ACE Day Nursery is open for more than 38 weeks of the year, we stretch funding claims across the period we are open. This means that funding equates to less than 15 hours per week.

### EXTRA SESSIONS

In an emergency it may be possible for your child to have an extra day (subject to availability) and this will be charged at £9.25 per hour (x 9 hours = £83.25 per day) if your child normally attends two or three days per week, or £8.33 per hour (x 9 hours = £74.97 per day) if your child normally attends four days per week. EYF is not available to cover part or all of the cost of any extra days.

### PAYMENT

Please make payment online to our Lloyds bank account (ACE Nursery School/Cam/Ltd – ACE Day, sort code: 30-13-55, account number: 03026919). We also accept payments via the government’s Tax-Free Childcare scheme and childcare vouchers. **All extras must be paid for on the day.**

## **WRITTEN NOTICE**

Each child is expected to attend ACE for at least two months. Parents must give seven weeks' notice in writing (which excludes our closure periods) before withdrawing their child from ACE Day Nursery (or reducing the number of days they attend). If this is not done, fees will be liable for the notice period and deducted from the deposit.
